# Schedule 'B' Public Works Report

We were able to get a few more things complete this month. Then not.

Cub root survey was completed throughout the RM. None was found in RM from survey, however some was found by an aerologist. We are not told which quarter(s). The ministry will be doing an awareness campaign and education.

Carmacks hauled 75,000 tonnes of product out of gravel pit on NW 17-46-24 W3M. They have completed the haul and the road sustained some damage from high usage. Carmacks had graders and a water truck on the road at times during haul. We have since graveled and graded the portion of Waseca Grid as well.

Gregoire Slough Construction was finally completed and Thomcat equipment has been moved out. Grass seeding has been put off until Spring. One quote has been received, I will attain a second. Discussion in regards to RM land south of tracks, possibly seeding to hay and a tender can be done each year for baling. Randy has been contacted to fence where needed on the N/S road. Signs arrived and will be placed next week.

Poppleton Construction is near completion. Final inspection will have to wait until Spring due to snow cover. Engineer recommends holding back the 10% until then.

Goodfellow Construction. Ulmer Construction has moved equipment down to site. With the change in weather they were unable to begin any construction. They will start in Spring as soon as weather and environment allows. Re-applications for environmental permits will be approximately \$800.00.

Engineering for Grid 675 pavement has begun and application for MREP and CTP will be filed shortly.

Ecology Pit area drainage was well done. Water has flowed away and toward river.

Pumping at Avelino Bertoia's, rumor suggested that the lagoon was flooded. Public Health Inspector met with Greg Bertoia and no concern was found in regards to a lagoon breech. The RM crew did set up the 6" pump at the intersection south by Chris Husch's in hopes to move some of the water lying here for the spring runoff.

# **BYLAW 6/2018**

# A BYLAW TO AUTHORIZE THE EXPROPRIATION OF LAND

The Council for the Rural Municipality of Hillsdale No. 440 in the Province of Saskatchewan enacts as follows:

- 1. The Council of the Rural Municipality of Hillsdale No. 440 deems it necessary to acquire 0.63 acres on the SE 17-44-23-W3M, described as SE 17-44-23-3 Plan No. AG2288 Extension 0, for the purpose of acquiring right of way for the construction of the road diversion
