BYLAW No. 2/2020

A BYLAW TO AMEND BYLAW NO. 4 - 2018 KNOWN AS THE BYLAW TO PROVIDE FOR THE ADMINISTRATION OF THE MUNICIPALITY AND TO SET FORTH THE DUTIES AND POWERS OF THE DESIGNATED OFFICERS FOR THE RURAL MUNICIPALITY OF HILLSDALE NO. 440.

The Council of the Rural Municipality of Hillsdale No. 440, in the Province of Saskatchewan enacts to amend Bylaw No. 4 - 2018 as follows:

1. **Part 3 Definitions** is amended by replacing 3(c) and 3(d) with the following new definitions:

3 (c) Chief Administrative Officer

"Chief Administrative Officer (CAO) means the Chief Administrative Officer of the Rural Municipality of Hillsdale No. 440 appointed to the position of Administrator pursuant of Section 110 of *The Municipalities Act*"

3 (d) Finance Officer

"Finance Officer means the person appointed as Finance Officer"

2. This bylaw shall come into effect on the days of its final passing.
